TERMS OF REFERENCE FOR THE FUND

1. The Kirk Session will determine the disposition of income from the fund. The Kirk Session may choose to delegate to a Committee decisions regarding the disbursement of grants from such income.
2. From time to time the Kirk Session will set and announce a date or dates for the submission of grant applications.
3. Grants will be made in support of program and personnel costs. Applications for grants for capital purposes will be considered only after all requests for program or personnel costs have been met.
4. The Kirk Session will consult regularly through its Investment Committee, to determine when the income from the fund may best be realized.
5. Additional capital for the fund will be received by the Kirk Session and added to the principal by the Trustees.

For 2015 and later, the deadlines for requests for funding from the Helen M. Watson fund will be April 30th and October 31st.

Criteria for Evaluation of Applications to the Watson Fund will be as follows:

<u>CRITERIA</u>	<u>WEIGHT</u>
The degree to which the application meets The Terms of Reference for the fund	40%
The degree to which the application is consistent with the Mission Statement of Saint David's and The Presbyterian Church in Canada	30%
The potential impact of the project, in relationship to the purpose of the Fund - missionary work	30%
